The Mayor's Office of Housing and Community Development ("MOHCD") of the City and County of San Francisco (the "City") requires **five (5)** business days to fund all down payment assistance loans from the time of approving the closing documents **IF** the title or escrow company is using one of the bank accounts that the City has already certified for outgoing wire transfers. Below is the most current list of the City-approved vendors that are setup for wire transfers. The wire setup is specific to Bank, Title/Escrow Company, and Title/Escrow Company Bank Account combination. In order for the City to wire out, **Bank Name, Beneficiary Account Name and Beneficiary Account Number**, must match exactly.

If you are using one of the banks listed above to receive wire transfers, you may provide us with your wire instructions for wire setup in advance to avoid loan funding delay; If you are NOT using one of the banks listed above and wish to add your wire receipt banks to be approved for the wire setup in the City's financial system, they must first become City vendors. Information about how to become a City vendor can be found at <https://sfcitypartner.sfgov.org/>

If the wire receipt bank is already a City vendor, but the wire location has not been set up as listed above, the City can only issue loan funds by check, which may take up to **additional five (5)** business days with a total of **ten (10)** business day funding period. MOHCD cannot rush funding to meet rate expiration and other deadlines. Lender arrangements must be made to allow for this funding period.
