MINUTES

1. Call to Order :

2. Approval of minutes of August 18, 2012 and October 16, 2012 / October 29, 2012 (community meetings)

Pushed to January 2013 meeting due to not having a quorum

3. Presentation by OEWD on Workforce RFP

Emylene Aspilla of OEWD -Workforce Division gave a presentation on Workforce's upcoming RFP. Funding for Workforce's RFP is about \$15 million, with \$5.6 million coming through the Workforce Investment Act, \$5 million from General Funds, \$3 million through Department of Labor grants and \$1.3 million in CDBG funds.

The release date for the RFP is December 10, 2012, followed by a bidder's conference on December 18th. Proposals are due on January 17th.

The RFP continues the services and strategies of Workforce of the past several years, with investments in **Sector Academies** (Construction, Healthcare, Tech, and Hospitality/Culinary), **Young Adult** services, **Job Readiness Services** and **One Stop/Access Points.**

Ms. Aspilla highlighted some current trends in the San Francisco labor market that underscored Workforce's services strategies. While there is anticipated hiring in the Tech sector, there are also growth projections in jobs such as waiters/waitresses, personal caregivers, housekeepers, janitorial, cashiers, chefs/cooks and office clerks.

Workforce also shared that input for this RFP came from various stakeholders including community meetings, educational entities, community based organizations and various oversight committees such as Youth Council, Community Advisory committee.

4. Director's Report

Brian Cheu informed/updated the committee MOH's request for proposal recently posted. Mr. Cheu stated that while for public services funding was not available due to MOH being in the midst their 3-year procurement, it did issue a RFP for capital grants and is seeking proposals for HOPE SF services and community building.

Mr. Cheu also reported to the committee on the community meetings held in October. One meeting took place in the OMI, while the second took place in Potrero Hill. Both meeting were well attended and affordable housing, access to workforce services and community safety were a common thread. Minutes of those meeting are available upon requests

Mr. Cheu also inquired about whether the committee would be interested in hearing about workforce services in other City departments (i.e. Public Utilities Commission, DPW, HSA) and initial response was yes. Mr. Cheu will follow up.

Mr. Cheu also informed the committee that SF voters approved the Housing Trust Fund.
