A LETTER FROM THE DIRECTOR OF COMMUNITY DEVELOPMENT

I am pleased to present our funding recommendations from our 2020-25 Request for Proposals (“RFP”).

This was the first time since November 2014 that Community Development made the vast majority of its services funding available for competitive bid. It was an opportunity for us to realign our grant making strategies with the most pressing needs of the San Francisco community, especially the needs of our low-income residents.

Those needs were articulated and advocated for in great detail by the nonprofit and program staff who responded to our RFP. We greatly appreciate the time and effort those professionals put into this process. Through their efforts, we received a total of 316 eligible proposals, requesting \$102,462,209 in annual grant funds. These totals represented an 186% and 244% increase, respectively, over our anticipated number of awards (170) and annual grant budget (\$42,000,000).

The need for grant dollars was highest in two of our service strategies. We received 106 proposals, totaling \$30,864,398, in the Community-Based Services strategy, compared to an anticipated number of awards and budget of 40 and \$5,500,000, respectively. We also received 62 proposals, totaling \$8,648,263, in the Convening and Collaboration strategy, compared to an anticipated number of awards and budget of 12 and \$1,000,000, respectively.

One of our primary goals for this RFP was to make funding recommendations that reflected our deep commitment to racial equity and trauma-informed systems. We feel strongly that the funding recommendations listed on the following pages have met this goal. In the coming months, we look forward to starting new – and deepening existing – relationships with nonprofit organizations led by and/or serving communities of color, as well as with all of our valued partners who help support the residents of San Francisco.

MOHCD cannot provide proposal scores and reviewer comments to applicants and/or members of the public, or receive formal appeals of our funding decisions, until after we have delivered official award notifications to applicants. We will send notifications once the public comment period has ended.

We encourage you to attend the public hearing on February 4, 2020 to share your thoughts about these funding recommendations. Your input is important to us.

OBJECTION & APPEAL PROCEDURES

MOHCD will send official award notifications to applicants once the public comment period has ended. At that time, if you disagree with our decision, you may file a formal appeal within five (5) business days of the award announcement (tentatively scheduled for February 24, 2020). We must receive the appeal on or before the fifth business day.

We will only accept appeals of non-responsiveness or an award decision in writing and in hard copy (i.e., email will not be accepted). The appeal must include a written statement of each of the grounds for appeal. An individual authorized to represent the respondent must sign the appeal. The appeal must cite all applicable laws, rules, procedures or provisions that we did not follow faithfully, as documented in this RFP. The appeal must specify facts and evidence enough for us to determine its validity. Disagreements about program quality or value do not constitute grounds for appeal.

You bear the risk of non-delivery within the deadlines specified if you use a mail service. You should use a delivery method that will establish the date our office receives your appeal. We will not accept any oral or electronic appeals.

A panel selected by MOHCD will review all eligible appeals, and the panel decisions will be final. If necessary, we will schedule a meeting with the respondent within ten (10) calendar days of receiving the appeal. We will review and attempt to resolve the appeal during this meeting.

Failure to object or appeal in the manner and within the times set forth above will constitute a complete and irrevocable waiver of any objection to this RFP or appeal of MOHCD's decision.

FUNDING RECOMMENDATIONS

When we released this RFP in late August 2019, we anticipated awarding approximately \$42,000,000 in annual grant funding from July 1, 2020 through June 30, 2025. The following funding recommendations total \$41,743,347 and represent our anticipated RFP awards for July 1, 2020 through June 30, 2021.

In most cases, these recommended grant awards will be setup initially as three-year contracts, from July 1, 2020 through June 30, 2023, with an option by MOHCD for a two-year extension to June 30, 2025. Annual grant allocations are subject to availability of funds. MOHCD has, at its sole discretion, the option to renew the grant agreement. The final terms and conditions of the grant are subject to negotiation.

All of these funding recommendations are strategy specific, and the funds provided must be used for the specific program purposes outlined under each strategy in this RFP. The following table (which continues through the last page) details all 316 proposals submitted through this RFP with our recommended annual funding amount.
