The Citizen's Committee on Community Development, Mayor's Office of Housing and Community Development (MOHCD) and Office of Economic and Workforce Development (OEWD) invite interested parties to attend a public hearing on the federally funded Community Development Block Grant (CDBG), Emergency Solutions Grant (ESG), Home Investment Partnership (HOME) and Housing Opportunities for Persons With AIDS (HOPWA) programs for fiscal year 2016-2017. The purpose of the hearing is to receive comments on the Draft 2016-2017 Action Plan, which includes preliminary funding recommendations for the four federal programs.

The Draft 2016-2017 Action Plan outlines community development and housing strategies and priorities that will be addressed and includes preliminary funding recommendations for projects that will be supported with the four federal funding sources during the upcoming fiscal year. The amounts of funding the City and County of San Francisco will receive from the U.S. Department of Housing and Urban Development (HUD) are as follows: CDBG - \$16,485,875; ESG - \$1,484,425; and HOME - \$4,136,238. The City and County of San Francisco will receive \$7,089,501 in HOPWA funding for San Francisco and San Mateo Counties. CDBG, ESG, HOME and HOPWA funds will be used to support the following three objectives, which are described in San Francisco's 2015-2019 Consolidated Plan:

- Families and individuals are stably housed;
- Community have healthy physical, social, and business infrastructure; and,
- Families and invididuals are resilient and economically self-sufficient.

The Draft 2016-2017 Action Plan will be available for public review and comment from March 17, 2016 through April 15, 2016.
