4. New Business

A. Panel Presentation – Mission Action Plan (MAP 2020)

Claudia Flores of the SF Planning Department (claudia.fores@sfgov.org, Dairo Romero of MEDA (dromero@medasf) and Chirag Bhakta of the SRO Collaborative provided a power point presentation overviewing the Mission Action Plan. The purpose of the mission Action Plan is to retain and attract low to moderate income residents and community servicing businesses, artists and nonprofits in order to strengthen and preserve the socioeconomic diversity of the Mission Neighborhood. It is community driven initiated and in 2015, community groups and City agencies came together to identify solutions to the affordability crisis impacting the Mission District community.  - Member binders at Orientation
 - o Updated bylaws
 - Would like presentations on: Economic Development and Small Site acquisition, Tech Connection- How is the tech sector being used for workforce development?
